

ORDER

No. 100, dated 26.5.2026

ON THE APPROVAL OF THE ORGANIZATIONAL STRUCTURE AND STAFFING OF THE NATIONAL *CANNABIS* CONTROL AGENCY

Pursuant to article 102, paragraph 3, of the constitution, article 10 of Law No. 9000, dated 30.1.2003, "On the organization and functioning of the council of ministers," and article 21 of Law No. 90/2012, "On the organization and functioning of the state administration,"

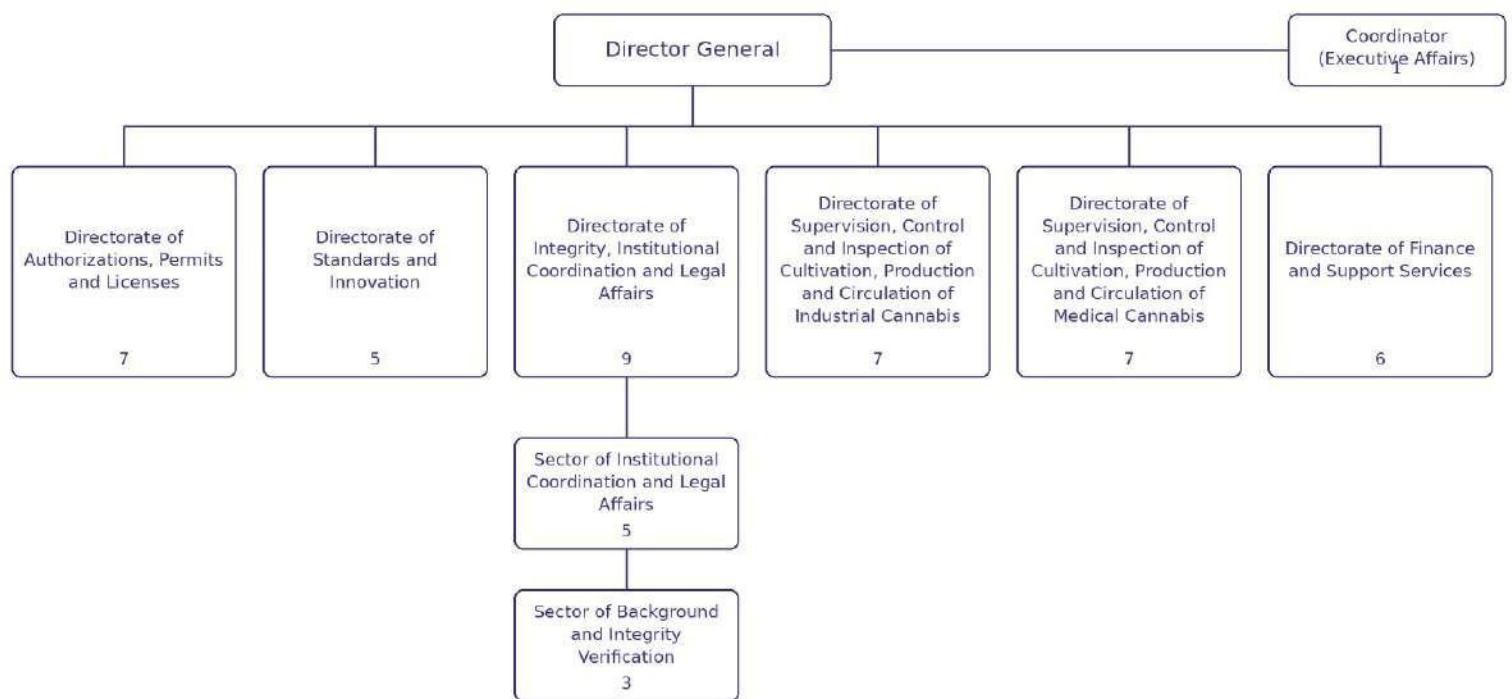
I ORDER:

1. The organizational structure of the National *Cannabis* Control Agency shall be in accordance with annex 1, attached to this Order and forming an integral part thereof.
2. The staffing structure (organizational chart) of the National *Cannabis* Control Agency shall be in accordance with annex 2, attached to this Order and forming an integral part thereof.
3. The total number of employees of the National *Cannabis* Control Agency shall be 43.
4. Prime Minister's order no. 56, dated 5.4.2024, "On the approval of the organizational structure and staffing of the National *Cannabis* Control Agency," is hereby repealed.
